# The Honourable Justice Hament Dhanji SC, Judge, Supreme Court of New South Wales

Justice Hament Dhanji was appointed as a judge of the Supreme Court of NSW on 20 September 2021.

Justice Dhanji graduated from the University of Sydney with a Bachelor of Laws and Bachelor of Arts degrees.

He was admitted as a legal practitioner in 1990 and practiced as a solicitor, working exclusively in criminal law being called to the Bar in 1997. He took silk in 2010.

He was a barrister in private practice at Forbes Chambers engaged predominantly in criminal defence work. In addition to first instance work across the range of criminal matters including complex corporate crime matters he had a substantial appellate practice. He appeared as lead counsel in a number of important cases in the High Court and appeared in approximately 350 cases in the Court of Criminal Appeal.

In addition to his defence work Justice Dhanji also conducted a number of prosecutions on behalf of the Commonwealth Director of Public Prosecutions, appeared as counsel assisting the coroner and represented clients before bodies such as the Police Integrity Commission and the NSW Independent Commission Against Corruption.

Since 2022, Justice Dhanji has been a Member of the Judicial Council on Diversity and Inclusion and since 2023, has been the patron for the Pacific Legal Association New South Wales Inc (PLAN).



#### Robert Hoyles, Executive Director Criminal Law, Legal Aid NSW

Rob is the Executive Director of Criminal Law for Legal Aid NSW. He is an accredited specialist in criminal law and holds an Executive Master of Public Administration from ANZSOG. He has previously held many roles within Legal Aid NSW including Deputy Director, EAGP Project Lead and Solicitor in Charge of a Sydney Indictable Team. He was the inaugural Solicitor in Charge of Legal Aid NSW's Port Macquarie office and previously worked as criminal defence lawyer in Sydney private practice, with the Aboriginal Legal Service and in four regional Legal Aid NSW offices. He commenced his career as researcher of NSW Court of Appeal.

Rob is presently appointed to the NSW Law Society's Criminal Law Committee, Ethics Committee and Specialist Accreditation Advisory Committee for Criminal Law. In 2008, he represented Australia in the Lawyers Cricket World Cup in Hyderabad, India.

# Madeleine Avenell SC, NSW Deputy Senior Public Defender

Madeleine was called to the Bar in 2004. Between 2004 and 2017, at the private Bar, her main areas of practice were criminal, ASIC regulatory, general commercial and corporate, torts especially professional negligence, and administrative laws.

In 2018 Madeleine was appointed as a Public Defender. In 2020 she was appointed Senior Counsel and, in 2024, a Deputy Senior Public Defender.

Since 2008 Madeleine has been a member of a NSW Bar Association Professional Conduct Committee.



# Michelle England, Deputy Director of Public Prosecutions

After practising as a solicitor at a large commercial firm and later at the Crown Solicitor's Office, Michelle was called to the bar in 2006. There, she had a trial and appellate practice in criminal and administrative law.

Michelle was appointed as a Crown Prosecutor and Acting Deputy Senior Crown Prosecutor in 2021, and in those roles appeared as lead counsel in numerous murder trials and criminal appeals. In February 2022, Michelle joined Director's Chambers as an Acting Deputy Director of Public Prosecutions. Since 2023, she has been the Director's representative on DCJ's Coercive Control Legal Reference Group.

Michelle has been an Australian company director of an international antislavery organisation and has run prosecutor training a number of times in Uganda, with a focus on gender based violence. Michelle has also been a member of NSW Bar Association Professional Conduct Committees and the Criminal Law Committee. In her spare time, she enjoys carpentry and cycling.



#### Hayley Dean, Solicitor Advocate, Legal Aid NSW

Hayley Dean has been a criminal lawyer for 18 years and joined Legal Aid in 2008 after working for the NSW DPP and Commonwealth DPP and is currently a criminal solicitor advocate attached to the Parramatta office. Hayley has worked for legal aid in the CCA, local courts, indictable, relief and committals across Sydney and regional offices and is now trying her hand at Coronial and Children's matters. Hayley obtained Specialist Accreditation in 2013. Hayley is a member of the Coercive Control Committee, having published a paper and presented seminars on Coercive Control.







#### Paul Townsend, Solicitor Advocate, Legal Aid NSW

After earlier careers as a high school teacher (English and History), and restaurant manager, Paul Townsend came to The Law in his late 30s, only ever wanting to practise as a criminal defence lawyer. He was admitted to practise in 1992 and achieved Specialist Accreditation in Advocacy in 1999.

After stints in private practice as an employed solicitor, followed by three years at Legal Aid at Campbelltown and Fairfield, he spent then nearly 5 years in his own practice. He returned to Legal Aid in 2001, and has been an Advocate since February 2004, mostly at Campbelltown. He has conducted as advocate well over fifty trials to verdict, and countless sentences in the District Court, as well as all other kinds of proceedings and applications. He was seconded to the Crown Solicitor's Office in 2010 as an Advocate, appearing as Counsel Assisting in a number of inquests, as well as a number of matters where he prosecuted serving police officers in AVO proceedings, which he enjoyed perhaps more than he should have.

# Belinda James, Senior Solicitor, Legal Aid NSW

Belinda began her legal career at the Campbelltown Legal Aid office in 2005 as a duty solicitor in the Local Court Team. After a number of years she moved to indictable work appearing instructing in District Court trials and sentences . In 2009 she moved to the Indictable Appeals Unit and later to the Indictable Unit Head Office Legal Aid. She returned back to Campbelltown in 2011 to work in the Children's Legal Service and later returned to Indictable work in Sydney and later the EAGP Team.

Belinda has also worked in the area of civil law in both the Civil Law for Aboriginal Communities (CLSAC) team travelling to remote NSW communities and also the Childrens Civil Law Service (CCLS) advocating for young people in out of home care, appearing in NCAT proceedings and providing advice about general civil law issues.

Belinda is currently employed In the Children's Legal Service at the Campbelltown Office .



# Cody Baxter, Senior Solicitor, Legal Aid NSW

Cody is a proud Boorooberongal Dharug woman and experienced criminal law solicitor with a specialist focus on complex mental health matters.

Cody is currently acting Solicitor in Charge of Port Macquarie Legal Aid office, leading a large multi-practice legal aid office on Birpai Country.

In 2022 Cody received her Masters in Forensic Mental Health. Cody has dedicated a significant part of career to achieving social change for Aboriginal Communities, including her work as Closing the Gap Senior Project officer in the Criminal Law Executive and her work with the Civil Law Service for Aboriginal Communities. In 2019 she won a Premiers Award for this work.

Cody began her career working in the Counter Terrorism and Special Tactics Command in NSW Police Force where she learned many lessons, one being her overriding passion for defence work.







# Professor Jan Breckenridge, Head of the School of Social Sciences and the Co-Convener of the UNSW Gendered Violence Research Network, University of New South Wales

Jan Breckenridge is a Professor and Head of the School of Social Sciences and the Co-Convener of the UNSW Gendered Violence Research Network, UNSW. She is also a Research Fellow of the UNSW Australian Human Rights Institute (AHRI). Jan has undertaken extensive work and research in the areas of gendered violence. Select research areas include domestic, family and sexual violence and workplace responses; economic and financial abuse; homelessness and the potential of safe at home programs for women and children affected by domestic and family violence.

Jan's research is oriented towards maximum impact in innovative social policy development, service provision and outcome measurement of effectiveness. Jan leads an evidence informed knowledge-exchange stream 'Gendered Violence and Organisations', which provides expert advice to government, private and third sector organisations on best practice policies and organisational response to employees and the management of customers affected by domestic and family violence, sexual assault and sexual harassment.



# Richard Wilson SC, NSW Deputy Senior Public Defender

Richard started in private practice in Canberra before working for the Western Aboriginal Legal Service in Walgett and later as Deputy Principal Solicitor of the Sydney Regional Aboriginal Corporation Legal Service. In 2004 he was called to the Bar. At 7th Floor Garfield Barwick Chambers he practised in crime – mainly as defence counsel but sometimes prosecuting for the Commonwealth.

In 2012 Richard was appointed a Public Defender and, in 2018, Deputy Senior Public Defender. He took silk in 2019 and his current practice is focussed on Supreme Court trials and appellate cases.

Richard has a keen interest in law reform (including resistance to bad law reform), has served for many years on the Criminal Law Committee of the NSW Bar Association and is presently Co-Chair of both the Bugmy Bar Book Project Committee and the National Criminal Law Committee of the Law Council of Australia.



#### Isaac Morrison, Solicitor Advocate, Legal Aid NSW

Isaac Morrison is a Solicitor Advocate on Birpai Country at Legal Aid Port Macquarie.

He regularly appears in the Local, Children's and District Court jurisdictions throughout NSW where he is briefed in a variety of criminal matters.

Isaac's success in defending cases involving the misuse of executive power sparked an interest in this area and led to him giving talks and publishing papers on police powers, criminal procedure, drug crime and advocacy. He also works as a casual academic in Criminal Law at Charles Sturt University.

Isaac joined Legal Aid in 2017. Prior to this he worked as a Federal Prosecutor at the CDPP where he spearheaded a number of high profile prosecutions including, famously, the possession of an illegally imported ferret.

#### Emmanuel Kerkyasharian, Barrister, Forbes Chambers


Emmanuel is a barrister at Forbes Chambers, Sydney.

Emmanuel is currently a member of the Legal Aid Criminal Appellate and Complex Criminal Law Specialist Barrister Panels.




# Diane Elston, Senior Solicitor, Legal Aid NSW

#### Nicholas Broadbent, NSW Public Defender



Prof Quilter has recently completed commissioned reports (with Prof Luke McNamara) for the Victorian Law Reform Commission, *Qualitative Study of Rape Trials in the County Court of Victoria*, 2014-2019 (August 2021) and the NSW Department of Communities and Justice, <a href="Experience of Complainants of Adult Sexual Offences in the District Court of NSW: A Trial Transcript Analysis">Transcript Analysis</a> (Aug 2023).

Since 2010 she has taught criminal law at the School of Law, UOW. Before commencing her full-time academic career, Prof Quilter spent a decade practising criminal and public law as a solicitor at the NSW Crown Solicitor's Office and as a barrister at the NSW Solicitor General and Crown Advocate's Chambers. Prof Quilter is a graduate of the University of Sydney (Arts, Honours Class 1 English with the University Medal, 1993), the University of New South Wales (Bachelor of Laws with the University Medal, 2000) and Monash University (Doctor of Philosophy, 2000).





#### His Honour Magistrate Daniel Covington, Local Court of NSW

His Honour was appointed as a Magistrate of the Local Court of New South Wales in January 2018.




# His Honour Judge Christopher O'Brien AM, District Court of NSW

Jocelyn commenced as Director, Grants in April 2018.








# Danielle Roth, Solicitor in Charge, Private Lawyer Quality Standards Unit, Legal Aid NSW

# Rajiv Baldeo, Barrister, Seventh Floor Garfield Barwick Chambers


