### How can I make payments?

Our payment options will be listed on the payment plan when it is approved and sent to you.

If you are receiving Centrelink payments, Revenue NSW can arrange to have your fortnightly repayments deducted from your Centrelink payment. If you would like us to set this up, please read the information below and sign the declaration.

### **Centrepay information**

Centrepay is a voluntary bill-paying service which is free for Centrelink customers. Use Centrepay to arrange regular deductions from your Centrelink payment.

You can start or change a deduction at any time. The quickest way to do it is through your Centrelink account online.

Australian Privacy legislation protects your personal information. I give permission for Revenue NSW to:

- disclose my information to Services Australia for the purposes of checking my account or billing number and the amount I want to pay, and reconciling my payment Deduction details
- decrease or suspend the nominated deduction when required to ensure my obligations under my payment plan are met
- make the agreed deduction each fortnight from my current Centrelink payments directly to Revenue NSW.

I understand that:

- I can change or cancel my Deduction at any time
- if the deductions from my Centrelink payments are cancelled for any reason, I am still required to make the agreed repayments on my payment plan with Revenue NSW
