- 1 At all material times the plaintiff was the driver and owner of a black Mazda 3, NSW registration number ABC 123.
- 2 At all material times the defendant was the driver of a red Toyota Yaris, NSW registration number DEF 456.
- 3 On 1 December 20xx, the plaintiff was reversing his car out of a parking space at the shopping centre on Burwood Road, in Burwood NSW, 2124.
- 4 Before the plaintiff reversed his car, the plaintiff checked his rear and side mirrors and the car park lane was clear.
- 5 As the plaintiff was slowly reversing his vehicle, the defendant's car suddenly entered the lane and collided with the plaintiff's car.
- 6 The collision was caused by the defendant's negligence.

Particulars of negligence

- a) The defendant drove too fast in the circumstances.
 - b) The defendant failed to keep a proper lookout.
 - c) The defendant didn't stop or control his car to avoid the collision.
 - d) The defendant failed to safely control his car.
 - e) The defendant didn't sound his car horn or provide any warning that he was approaching.
- 7 As a result of the defendant's negligence, the plaintiff's car was damaged.

Particulars of damage

- a) Repair to back bumper \$350.00
- b) Repair to back left side boot lid \$350.00

- 8 The plaintiff has paid a total sum of \$700.00 to repair the damage caused by the defendant's negligence.
- 9 The plaintiff has demanded payment of \$700.00 from the defendant.
- 10 The defendant has failed to pay this amount to the plaintiff.
- 11 The plaintiff claims \$700.00.

- Paying the plaintiff that part of the money that is claimed.
- Filing a defence in relation to the part that you do not believe is owed.
